# INDUSTRIAL INDEPENDENT SCHOOL DISTRICT ORDER OF VOTER-APPROVAL TAX RATE ELECTION

A special election is hereby ordered to be held on November 5, 2024, pursuant to Texas Tax Code Sections 26.05 and 26.08 to approve the ad valorem tax rate for Industrial ISD because the adopted rate exceeds the IISD Voter-Approval Tax Rate ("VATR").

At the Election, the ballot proposition shall be submitted to the qualified voters of the District using the language required by statute:

"Ratifying the ad valorem tax rate of \$1.0544 in Industrial ISD for the current year, a rate that will result in an increase of 10.5 percent in maintenance and operations tax revenue for the district for the current year as compared to the preceding year, which is an additional \$902,492."

Early voting by personal appearance will be conducted beginning on October 21 and ending on November 1, 2024.
